Florida's Risk Screening process and Healthy Start services were enacted by state legislation in 1991 with the goals of reducing infant mortality, reducing the number of low birth weight babies and improving health and developmental outcomes for all Florida's babies.

Completing the Prenatal and Infant Risk Screening forms are valuable for all mothers and babies regardless of age, race, or economic status. Thank you to our local community partners for your support in the moms and babies of Brevard, without your support we would not be able to reach those in need of assistance.

The information below explains the table to the left: **PROCESSED SCREENS**

This number should reflect the number of new patients seen in your office during the reporting period, as Florida Statute 383.14 requires that every prenatal patient receive a prenatal risk screening at her first visit.

CONSENT TO SCREEN

The consent-to-screen rate reflects the number of patients who consented to be screened.

In Brevard, 89% of all new pregnant women consented to the risk screening and 91% of all new moms consented to the infant risk screening at the hospital. 9 out of 14 prenatal offices had over 90% of their patients consent to the prenatal screen and 3 out of 4 of our birthing hospitals had over 91% consent to the infant risk screen.

REFERRED TO COMMUNITY CONNECT

This number reflects the number of patients that were marked referred on the risk screening.

These are the Brevard families that we contact by phone to let them know about home visiting programs and other community resources available to them as a pregnant woman and a mother with an infant. In 2020, 70% of all pregnant women and 49% of infants who consented to the screening were referred for community resources.

Racial Disparities In Health

Health disparities are a particular type of health difference that is closely linked with social or economic disadvantage. Health disparities adversely affect groups of people who have systematically experienced greater social or economic obstacles to health based on their racial or ethnic group, religion, socioeconomic status, gender, mental health, cognitive, sensory, or physical disability, sexual orientation, geographic location, or other characteristics historically linked to discrimination or exclusion.

• Prematurity is a leading cause of infant deaths in Florida and across the country, and can lead to life-long health issues for infants that survive. There are also considerable racial disparities in premature birth –the preterm birth rate. In Florida, the preterm birth rate among black women is 52% higher than the rate among all other women.

• Infant Mortality: Infant mortality is the death of an infant prior to their first birthday. National and state level data have consistently demonstrated that Black infants are twice as likely to die in infancy in comparison to White infants. Such a health disparity, or differing health outcome in a socially disadvantaged group, is concerning and should be addressed in order to ensure health and wellbeing of the population.

Infant mortality and the infant mortality rate reflect the health and well-being of the population's women of reproductive age and their infants as well as the quality of the health care available.

In 2019, in Brevard County: The rate per 1,000 live births of Infant Mortality (0-364 days from birth) (All) was 5.6 compared to Florida at 6.0. In 2019, in Brevard County, white infant deaths were at a rate of 4.0 and black/other infant deaths were at a rate of 11.2.

WIC provides the following at no cost:


- Healthy foods

- You must be moderate or low income
- You do not have to be on public assistance to apply
